Substance Abuse Detox Provider (Adult and/or C&A):

Employment Services Provider (Adult and/or C&A):

- Job Development, Placement and Training
- Community Support- Individual (service can be employment-specific only or be traditional CSI with the capacity to address employment).

Peer Support Provider (Adult and/or C&A):

- Peer Support Services

Consumer/Family Support Provider (Adult and/or C&A):

- Respite Services
- Consumer/Family Assistance

SA Residential Provider (Adult and/or C&A):

- Diagnostic Assessment
- SA Residential Treatment

MH Residential Provider (Adult and/or C&A):

- Diagnostic Assessment
- MH Residential Treatment

Other Residential Provider (Adult and/or C&A):

- To be determined

Adult Opioid Maintenance Treatment Provider:

- Diagnostic Assessment
- Opioid Maintenance Treatment

Adult Intensive Services Provider:

- Diagnostic Assessment (and one or more of the following):
- Assertive Community Treatment
- Community Support Team

Adult MH Intensive Day Treatment Provider:

- Diagnostic Assessment
- Intensive Day Treatment

Adult Substance Abuse Day Service Provider:

- Diagnostic Assessment
- SA Day Services
- Job Development and Placement
- Community Support- Individual

Adult Mental Health Day Provider:

- Diagnostic Assessment
- Psychosocial Rehabilitation
- Job Development, Placement and Training
- Community Support- Individual

C & A Intensive Provider:

- Diagnostic Assessment (and one or more of the following):
- Intensive Family Intervention
- Community Support Team

C & A Day Provider:

- Diagnostic Assessment (and one or more of the following):
- C&A Mental Health Day Treatment
- C&A Substance Abuse Day Treatment

C & A Activity Services Provider:

- Diagnostic Assessment
- Activity Therapy (**use new definition**)

C&A Foster Care Provider:

- Treatment Foster Care
